SINGAPORE GOLF ASSOCIATION (“SGA”)

TERMS OF REFERENCE: ATHLETES’ COMMISSION (AC)

1. **MISSION**

To represent the views of Singapore national golfers within the Singapore Golf Association.

2. **OBJECTIVES**

- 2.1 To consider all questions and matters related to national golfers and advise the SGA Executive Board.
- 2.2 To represent the interests of national golfers and where appropriate, make recommendations to the SGA Executive Board.
- 2.3 To serve as a voice for national golfers in the SGA Executive Board.
- 2.4 To advise and assist the SGA Executive Board and its Subcommittees in promoting Olympism, sporting excellence, fair play and athlete development.
- 2.5 To maintain contact and good relationships with ACs of other NSAs and SNOC.

3. **COMPOSITION**

- 3.1 The Athletes' Commission shall comprise of no more than five (5) elected members, who are either past or present national golfers, including the Chairperson who must be a former national golfer.
- 3.2 To be eligible for nomination and appointment to the Athletes' Commission, the candidate must be at least 18 years of age (only candidates applying for appointment as the Chairperson of the AC need to be at least 21 years of age), be a Singaporean, must not have a criminal record and, have never been sanctioned for a doping offence.
- 3.3 The members of the AC shall be elected by national golfers who have represented Singapore in international golf competitions within the past twenty-four (24) months, who are at least 18 years of age.

- 3.4 The term of office of the AC members and their term limits, if any, shall follow that of the Executive Board.

4. **PROCEEDINGS OF THE AC**

- 4.1 The AC may meet as often as necessary at such place and time and regulate their meetings as they think fit for the dispatch of business and shall, upon the request of the SGA Governing Council and/or the SGA Executive Board, take instructions therefrom and report thereto on such business as the SGA Governing Council and/or the SGA Executive Board may direct. All meetings may be convened by the Chairperson of the AC. Such meetings may also be convened at the request of a majority of the AC members.

- 4.2 At all meetings of the AC, a simple majority either present physically or virtually, shall form a quorum.

- 4.3 Every decision shall be decided by a simple majority of the votes cast. The Chairperson of the AC shall have a casting vote at all meetings of the AC.

5. **REPRESENTATION IN THE SGA EXECUTIVE BOARD**

- 5.1 The Chairperson of the AC shall be appointed as an Executive Board member with voting rights and shall represent the AC in the Executive Board until the expiry of his/her term as Chairperson of the AC.
