Candidate Eligibility

To be eligible for nomination and appointment to the Athletes' Commission, the candidate must be:

1. At least 18 years of age (only candidates applying for appointment as the Chairperson of the AC need to be at least 21 years of age) as of 17 July 2026.
2. A Singaporean who must not have a criminal record and have never been sanctioned for a doping offence.
3. A past or present national golfer (Sport Singapore carded athlete), including the Chairman who must be a past national golfer (Sport Singapore carded athlete).

Voting body

Eligibility for the members of the voting body is as follows:

1. National golfer (Sport Singapore carded athlete) within the past twenty-four (24) months (18 July 2024 to 17 July 2026 inclusive);
2. Has represented Singapore in international golf competitions within the past twenty-four (24) months (18 July 2024 to 17 July 2026 inclusive); and
3. Is at least 18 years of age as of 17 July 2026.

Elections

1. The elections for the AC Chairperson and members will be held by 31 July 2026.
2. If there are no applications for the AC Chairperson, the members of the voting body may elect and appoint a member from amongst the applicants to chair the AC and the AC shall inform the Association of the identity of the AC Chairperson as soon as reasonably practicable.

3. Further instructions on voting and the list of applicants for the AC and the AC Chairperson will be set out in a voting form which will be sent to the eligible voters by 24 July 2026.

**Further instructions on voting and the list of applicants for the AC and the AC Chairperson will be set out in a voting form which will be sent to the eligible voters (voting body) by 24 July 2026. The eligible voters must fill up the voting form in accordance with the instructions set out therein and submit the voting form by 31 July 2026.*

4. The AC Chairperson shall be subject to approval by the SGA Governing Council at SGA's 65th Annual General Meeting.
